CHILDHOOD CANCER SUPPORT PROGRAMS - MaxLove Project is childhood cancer nonprofit organization that provides educational, programmatic, and direct support that aims to improve quality of life and lower cancer-related health risks for children in treatment and in survivorship. Outside of MaxLove Project primary programs-such as the Healing Narrative, Love & Light Kits, Fierce Foods Academy, and Camp Make & Believe-the general programs consist of community engagement and community education events. Examples of such events are our monthly "Thrive Parties" at Children's Hospitals, elementary school programs such as our Fierce Foods Challenges, and Super Sibs parties at the MaxLove Project office. Collectively, these events reached over 2,500 community members in 2015.
