NEAR THIKA, KENYA

In Kenya, GCL works through Give A Child Life Kenya, a legally registered nonprofit. Efforts are focused in Kiandutu, a major slum with

25,000 people near Thika. Young children here frequently suffer from malnutrition, diarrhea, and pneumonia, the leading causes of death for

children under five worldwide. HIV affects about 20% of the adults and has orphaned many little boys and girls.

• Changed the lives of 150+ families by giving them Door-Step Gardens, space-saving bags in which fresh, healthy vegetables grow in abundance. Made from used flour bags, the bags cost almost nothing and greatly improve children's consumption of leafy green vegetables.

They also enable families to earn a little income. To date, more than 770 bags have been created.

• Provided preschool (with lunch!) to 47 little boys and girls, giving them a safe place to play and their mothers an opportunity to work.

MABATI BULBS (SOLAR LIGHT) SUMMARY: Pre-post surveys of those who received Bulbs last year indicated that the light made it significantly easier to see a face, find things, prepare food, clean, and prevent burns and falls. Happiness also increased. When the Bulbs were installed in schools and preschools, children could see to read and study inside the buildings. This is urgently needed, as less than half preschools have electricity. The same was true at homes; before, children had to read their books outside. Mothers joyfully reported that having the Mabati Bulbs made it possible for them to see enough to clean thoroughly...a big step towards keeping the family healthier.
