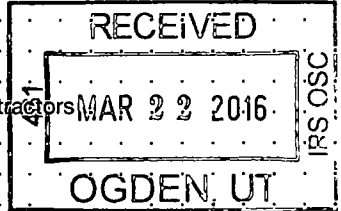

Give A Child Life's (GCL) mission is to help save the poorest children in the world at the time when it matters most age five and under GCL provides basics such as food and medicine, as well as low-cost, high-impact projects such as solar bulbs and gardens With a vision to transform slum life for children, GCL offers feeding programs, emergency food and medicine, child care, and Kids' Club, mothers benefit from support groups, small business assistance, health training and hand-washing training In 2015, over 1000 families and 3000 children received assistance.

KIANDUTU IN THIKA, KENYA In Kenya, GCL works through Give A Child Life Kenya, a legally registered nonprofit Efforts are focused in Kiandutu, a major slum with 40,000 people near Thika Young children here frequently suffer from malnutrition, diarrhea, and pneumonia, the leading causes of death for children under five worldwide HIV is a major issue in the community. Many little boys and girls are orphans.

MABATI BULBS While about a third of slum homes have electricity, many families cannot afford to use it. Few have windows and opening the door is dangerous, so most home interiors are completely dark during the day. In the blackness, mothers have used paraffin instead of water for cooking--children can't find things or see each other's faces--no one can read. Made from water-filled recycled soda bottles, the Mabati Bulbs enable children to read inside their homes and mothers to clean. Germs including Tuberculosis are reduced by the UV light.

During 2015 GCL installed more than 1,000 Mabati Bulbs, improving young children's health, development and well-being.

DOOR STEP GARDENS Made with grain bags, soil, manure and rocks, Door-Step Gardens are an inexpensive way to improve children's health. Each bag holds 32 nutritious vegetable plants in about 24", an important feature in crowded slums. The Door-Step Gardens improve the look of the community. GCL's monthly Garden Club instructs families on how to maintain the gardens.

During 2015 GCL helped create over 800 Door-Step Gardens. Over 600 adults and 1800 children are healthier.

EMERGENCY FOOD was provided to 60 families. EMERGENCY MEDICINE to 50 children and 9 adults. OTHER ASSISTANCE was provided to 55 families, including clothing, rent and bus fare, milk and other nutritional support, mattresses, blankets, etc.

#### OTHER 2015 ACCOMPLISHMENTS

- Started regular monthly home visits to closely monitor children in trouble. Families receive a small food packages on every visit.
- Provided a hot, nutritious lunch to 120 children daily during the three months of school holidays.
- Provided morning porridge and a hot lunch to 35 children and adults in desperate need five days a week.
- Provided porridge flour, milk, margarine, sugar and firewood so 130 infants in home or church-based baby care centers.
- Gave more than 100 children new rubber shoes to prevent jiggers and other infections.
- Launched an infant care center with a feeding program next to our compound.
- Installed a propane stove in our cooking room.
- Moved out iron sheet walls to create a large space for children to play. Space is at a premium in the slums.
