Support Serices: Build Futures helps these youths obtain identification such as California ID and social security card. We work with employment partners and staffing agencies for job search, skill training and job placement. We provide basic necessities such as food, bus passes, phones, and clothing. We help address legal, medical, and mental health issues. We provide extensive initial client specific one on one case management in the first two or three months and long term follow up.
