The authorized body will consist of the President of the Board of Trustees, unless for a particular compensation arrangement, the President of the Board of Trustees designates a different authorized body. The compensation arrangement will be included and part of the annual budget for the Laguna Playhouse.

2. Prior to making its determination, the authorized body will obtain and rely upon appropriate data as to comparability. The Theater Communications Group salary survey will be used for benchmark purposes.

3. The authorized body adequately and timely documents the basis for its determination concurrently with making that determination.
