SINCE CHILDREN IN FOSTER CARE ARE TYPICALLY GIVEN 2 TRASH BAGS TO TRANSPORT THEIR BELONGINGS, WE TRY TO GIVE THEM OUR SWEET CASES INSTEAD. THIS IS OUR BIGGEST PROGRAM, AND IT IS GROWING EVERY YEAR!
