THE CLUBHOUSE PROGRAMS OFFER SELF-HELP, SUPPORT AND EDUCATION. THE PROGRAM OFFERS CLINICS AND CLUBHOUSES IN COSTA MESA, GARDEN GROVE AND LAKE FOREST. THE PROGRAM SERVICED 2,560 INDIVIDUALS DURING THE YEAR.
